ORDER

1. The Principal, Sree Anjaneya College Of Paramedical Sciences, Kozhikode, for short, the Paramedical College has submitted the draft prospectus to fill up 35% Management quota and 15% N.R.I quota seats in respect of BPT, BSc Opt and BSc MLT Courses for the academic year 2024-25 before Admission Supervisory Committee, hereinafter referred to, as the Committee for approval. The Paramedical College has also submitted the affiliation order obtained from the Kerala University of

Health Science to conduct the aforesaid courses for the current academic year.

2. On scrutiny of the draft prospectus and the affiliation order submitted by the Paramedical College, it is found that the Paramedical College has got affiliation for conducting the following paramedical courses for the academic year 2024-25.

- **3.** The Committee finds that certain modifications as enumerated hereunder are necessary as condition precedent to the approval of the draft prospectus submitted by the Principal of the Paramedical College.
 - (i) Instead of the clause IV in the prospectus stating that "submission of more than one application by a candidate will lead to rejection of the candidature", the following clause shall be substituted. "Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application".

(ii) Under the head of 'Admission & Payment of Fees', The Paramedical College is not entitled to retain the first-year tuition and other fees, if the student discontinues the course before the last date of closing of admission stipulated by the competent authorities. Therefore, the Paramedical College shall modify the clause specified in the Prospectus under the 'aforementioned head' accordingly.

The clause relating to 'liquidated damages' shall be deleted and the same shall be substituted by the following words: "Claim, if any, for liquidated damages against any student shall be determined by appropriate proceedings before the competent Civil Court".

College shall modify the clause in the prospectus as stated above.

(iv) The Paramedical College has included in the prospectus the tentative schedule for admission. Tentative schedule provided in the prospectus is modified with the following changes in the dates:

- (v) Spot admission, if any, required for filling up the seats lying vacant, shall be done only after obtaining the prior permission of the Committee.
- (vi) The closing date of admission should be as per the notification issued by the KUHS and the Government of Kerala.
- **4.** The draft notification submitted by the paramedical college is hereby provisionally approved. The approved notification shall be published in

the dailies and the electronic media. No other notification except the approved one shall be published.

- **5.** The Principal of the Paramedical College is directed to obtain prior approval from the Committee at every stage of the admission procedure.
- **6.** Applications shall be invited by the Paramedical College only through online. No other mode of inviting application shall be entertained.

The online application should contain the following particulars:-

- → Name of the Paramedical College with Address and Registration details should be included in the online application from.
- → The online application form should contain Auto generated Registration/ Application Number and auto generate date and time of submission of application.
- → The facility for uploading the photograph and signature of the candidate shall be provided.
- → The category/quota shall be clearly specified in the online application form.
- → The declaration of the candidate, as to the details provided in the application are true to the best of knowledge, should be included in the online application form.
- → The facility for taking print out of the application shall be provided to the candidate by the Paramedical College.

Principal of the Paramedical College shall ensure that the aforesaid particulars are included in the online application form.

- 7. The Principal of the Paramedical College shall ensure that the documents submitted by the aspirants for the N.R.I seats conform to the guidelines and directions contained in G.O (Rt) No.375/2020/H&FWD dated 22.02.2020.
- **8.** Until orders are issued by Fee Regulatory Committee (FRC) regulating the levy of fees for 2024-25 from the students, the paramedical college may collect the same fee as was levied during the previous years. Fee thus collected, however, will be subject to the orders of FRC regulating the fees for the current academic year.
- **9.** Paramedical College shall make the candidates aware of the amount of tuition fee, special fee, hostel fee and other fee details at the time of admission. This is necessary to avoid litigations and complaints.
- **10.** Principal of the Paramedical College is directed to collect the tuition fee and special fee only through online payment/ Cheque/DD/RTGS/IMPS etc. If any amount is collected from the students, other than the fee fixed by the Committee, it would be considered as collection of capitation fee.

- 11. Certificates in respect of the community/minority quota category students shall be obtained from the revenue authorities as per the directions contained in the judgment of the Hon'ble High Court and the Hon'ble Supreme Court.
- 12. The colleges have no right to retain the certificates of the students who may leave the college midway nor to refuse the request for issuance of T.C. The above documents shall be released to applicant-student without any delay. Paramedical College is not entitled to retain the first year tuition and other fees, if the student discontinues the course before the last date of closing of admission stipulated by the competent authorities
- **13.** Prospectus submitted by the Paramedical College, subject to the modifications, corrections etc. directed to be made as per this order, is provisionally approved for 2024-25.
- **14.** Principal of the Paramedical College is also directed to submit the modified prospectus before the Committee after making the aforementioned corrections and incorporating the modifications, at the earliest. The modified prospectus alone shall be uploaded in the College website.
